Change doesn't happen overnight. But, how do you know if you are moving in the right direction?

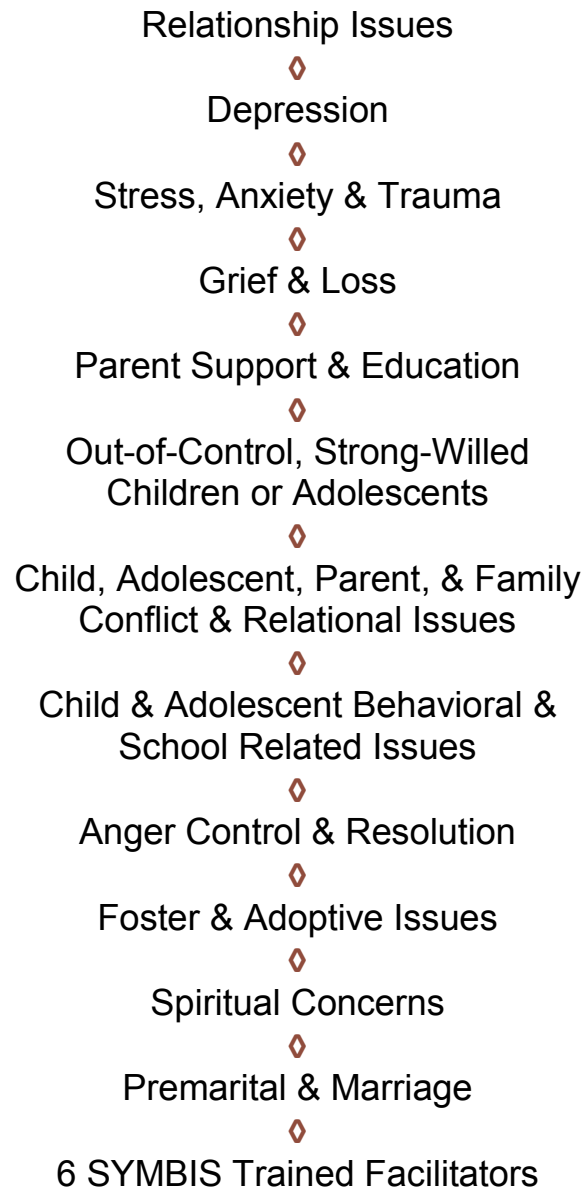

Our therapists work from a holistic model and provide clients with tools to develop their emotional, social, relational, spiritual, and physical wellbeing.

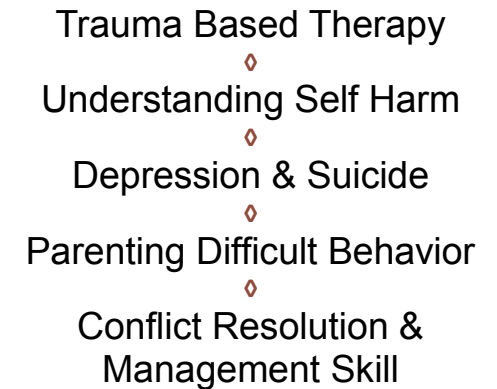
